PRESIDENT'S REPORT SEASON 2018/19

It is with great pleasure that I report on Season 2018/19, my first season as President of Metro West District. Having taken on the role after the departure of the former President towards the end of the previous season, there were a number of initial changes that were implemented to enable a more efficient running of the district. These included:

- The creation of a member electronic mailing list using Mailchimp software to enable consistent, formatted & efficient communication of information to all individual members of the district;
- A dedicated delegates mailing list using Mailchimp to enable efficient communication to all club representatives; and
- An updated website to allow customised content and better usability on desktop, tablet & mobile devices.

Throughout the season a number of further changes were implemented, including:

- An online application process using JotForm for Metro West service awards & grant applications; and
- Online invitations (including online RSVP's) for attendance at events including the Metro West presentation night.

All five of the initiatives above were implemented to create more efficient processes (replacing previous manual processes), and ultimately enabled members of the Management Committee to put time into other roles & functions of the district. It is my opinion that these processes contributed in part to:

- One of the largest numbers of grant recipients;
- No one contacting the district after presentation night in regards to missed grant applications;
- No missed invitations for our district presentation night; and
- The largest presentation night turnout in recent years.

There were a number of other initiatives that will hopefully set a precedent for the coming seasons, including procuring a sponsor to help fund part of the purchase of Metro West tee-shirts for our Optus Junior Dolphin Meet finalists and the planning of a Metro West district trip (which although it has taken place – was two weeks into the 2019/20 season).

From a performance side the district continues to excel. Some highlights in Season 2018/19 included:

- Melbourne University Propulsion's Thomas Pearson being selected on the Australian Team for the Junior Pan Pacific Championships in Fiji;
- Laverton's Paris Vasta being selected for the Swimming Victoria Touring Team for the Singapore Open Championships;
- Melbourne University Propulsion's Johan Stickland being selected on the Victorian Team for the State Teams Short Course Event in Canberra; and
- Four national medallists, being Tara Gallop from Hoppers Crossing, Paris Vasta from Laverton, Adam Selwood from Melbourne University Propulsion, and Stone Ma from North-West Aquatic.

One of the great things about our district is that elite performances are spread across the clubs, and the fact that our four national medalists hailed from four different clubs, indicates the quality of programs spread throughout our district.

Finally, as President I would like to thank the team behind the scenes who keep the district running and who have played a vital role in this season being such a success. When I stepped into the Presidents role, it was the continuation of the Vice President, Jamie Taafe, our Treasurer Janine Boyton & Competitions Officer, Julie Walsh, that ensured the district continued to function and provide opportunities for our members & clubs. With the additional support of Secretary, Seb Bettiol & District Referee, Margaret Arnold, I am extremely proud of what we have achieved as a district in Season 2018/19 and believe that we are in a better position than twelve months ago to continue in our quest to provide opportunities & support for swimmers in Melbourne's west.

DISTRICT REFEREE'S ANNUAL REPORT 31st July, 2019

The 2018/19 season has been successful for Metro West. I have been able to put some officials through workshops and sign off their qualifications; however, we could do better. Please seek interest from your members to become an official. I will then arrange with you a time for me to come to your club to run the appropriate workshops.

This year I reverted to the previous method of allocating officials with a very positive response. All Clubs have been able to have their required number of officials available for all meets this season. Thank you very much for your cooperation with these requests.

Thanks to all those people who have willingly given their support and I hope that we will be able to recruit more people to begin their journey as a swimming official so that the sport will continue with a fair deal for all competitors.

Margaret Arnold District Referee Competitions Report 2018/2019.

The first event on the district calendar was the proficiency meet. A few clubs in the district support this meet– Swimland, Melton and Hume had a few entries and a couple of other clubs that had one or two entrants. We need to continue to run this event for the swimmers that have started their progression through the awards. This season we will trial running it with the encouragement meet. This will enable us to have timekeepers for the encouragement meet and this will also allow the swimmers to have time between their proficiency events. – September the 8^{th} .

The next event was the Junior Dolphin Selection trials – This was a new format. Now including the 11 and 12 year olds and 100m events. This was a nightmare for the district to run as the 11 and 12 year olds could swim the 50m events or the 100m events – if they swam, the 100m events then we had to try to get their 50m times for relay selections. We did send in feedback about the new format – this event was usually finished by 12 but now it is extended to late afternoon – so the little ones have to wait around all day (in the freezing cold) outdoor pool. Too long a day for them. I just noticed the format is the same this year.

District championships went very well – this event was again held over the 4 days (still a few complaints about two weekends in a row.) but the consensus is that it is good to get it over and done with. Went through without a hitch. We are trialing these in October this year as the Feb/Mar Calendar is quite full.

All juniors also went really well – as we split the age groups so there was less crowding at the Broadmeadows pool.

The last event for the season was our short course meet. The event is usually very popular but this season we were about 100 swimmers down. Not sure if the introduction of Swim Central had anything to do with it or maybe it was because we changed the program. After answering hundreds of emails regarding times or events the meet ran without a hitch. I think everyone enjoyed the day and it was a nice early finish. Another big thank you to Margaret and Damian for helping and also thank you to the officials.

Above all, I think the district have had a very successful year, the annual Presentation Night was very well supported more than 250 attended. Biggest crowd ever.

On a final note - I personally would like to congratulate all the award winners in the district and would like to wish them very best in the current season.

The calendar is done – thank you Ros. All the events are currently listed. I have booked the Broadmeadows Pool for the Proficiency Meet /Encouragement Meet and Craigieburn has been booked for the District Champs and 2019 Metro Junior Selection Trials in October due to the refurbishment of Broady.
